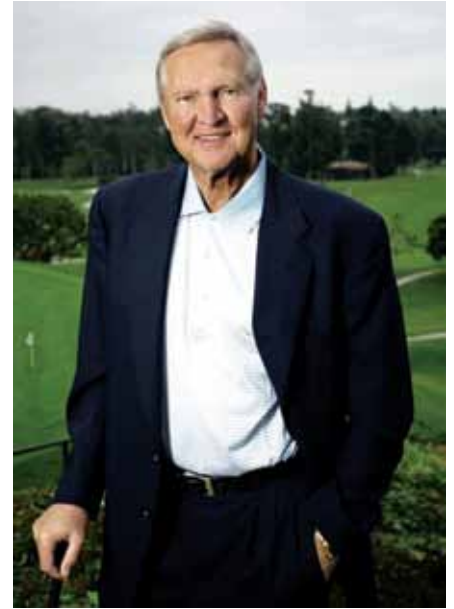

New Hope Benefit**

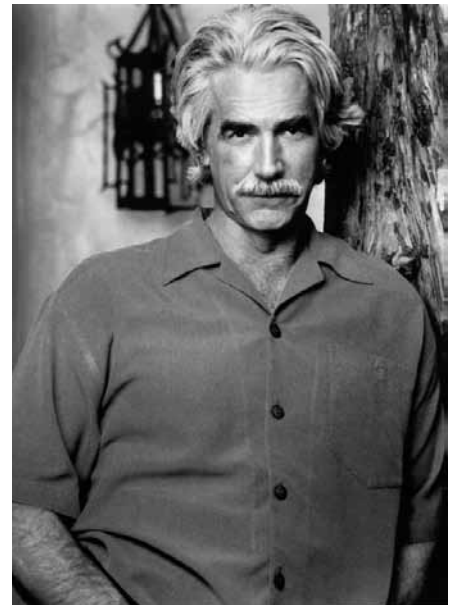
Jerry West

Basketball icon, humanitarian and sports legend, Jerry West, will be receiving the Giving New Hope Award. A 14-time All-Star, one of basketball's best shooting guards and a member of the Los Angeles Lakers, Mr. West led the Los Angeles Lakers to dominance in the last quarter of the 20th century. Mr. West is the model for the silhouetted figure focal on the NBA logo. As an NBA executive, he shaped the Lakers championship dynasties of the 1980s and early 2000s. Off the court, he has committed his time as a community leader to bring awareness and hope to those who need help and support in our community. In May 2009, he was named the Executive Director of the Northern Trust Open and helped further the organization's impact and increase community engagement in its charitable mission. Thanks in no small part to Mr. West's efforts, the 2010 Northern Trust Open was a tremendous success and generated \$1.48 million for local Los Angeles charities.



Sam Elliott

One of the earliest members of the Children's Burn Foundation's Board of Trustees, Sam Elliott has been steadfastly dedicated to helping child burn survivors and increasing burn prevention programs. Sam Elliott is only the second person in the Children's Burn Foundation's history to be honored with the prestigious Spirit of Humanity Award at this year's benefit. Sam Elliott most recently appeared in the detective drama *The Big Bang* in the role of 'Simon Kestral.' Mr. Elliott first gained acclaim with his performance in the title role of *Lifeguard*. Other notable feature films include *Tombstone*, *Gettysburg*, *The Big Lebowski* and *Thank You for Smoking*. On television, he was nominated for an Emmy and a Golden Globe for his role in *Buffalo Girls*. He will next appear in the upcoming thriller *The Company You Keep*, being directed by Robert Redford. In addition to his illustrious professional career, Mr. Elliott has been a pillar in the leadership of this organization. He has generously dedicated his time, voice talents and resources to further the mission of the Children's Burn Foundation.

Meet Judah and Kevin, two young burn survivors who received new hope this year because of the Children's Burn Foundation...

Judah

One day, Judah, a six-year-old boy, was visiting his grandmother. He innocently followed his older cousins out to watch them "buss bamboo"—a popular recreational activity for older boys in Trinidad, but for six-year-old Judah it was a horrific experience. As the boys playfully blew into a long bamboo stick, they lit a fire to make a popping sound with the stick, but when Judah tried it, everything went wrong. The bamboo split, spraying fire and engulfing young Judah in flames. As soon as we were contacted, the Children's Burn Foundation moved quickly to relocate Judah and his family to Boston, getting Judah accepted to Shriners Hospital in Boston for treatment and providing assistance for their stay while Judah was being treated. Judah's burns were so severe that they caused his skin to fuse together, restricting him from moving his neck. He has had his first successful surgery to remove scar tissue on his neck, but there are many more surgeries to come.



Kevin

Four-year-old Kevin was admitted to Torrance Memorial Hospital Burn Unit; he had severe burns to 40% of his body. Kevin was burned while playing with his siblings in the yard of their housing complex when he found a lighter and a hair spray bottle. Luckily, Kevin survived, but he had to undergo multiple surgeries and spend more than a month in the hospital with most of his body completely bandaged. The Children's Burn Foundation reached out to do whatever they could to assist Kevin and his family during his hospital stay. We even purchased a new mattress, pillows, and bedding for Kevin. A very special moment came recently when Kevin was reunited with his twin brother for the first time since his accident as they celebrated their 5th birthday in the hospital.



July 2011 We Launched NEW SUPPORT GROUPS!! For Children and Families



The unique challenges that a child burn survivor faces affect not only them but their parents and siblings, too. Parents want so much to help their children, but they don't always know how, and the child burn survivors need help coping with the scars and the questions. That's why we began Child & Family Support Groups. These professionally-facilitated support groups convene every 2nd and 4th Tuesday of each month, and are split by age: 5-12 and a parent group. The response from families has been overwhelming and we have received wonderful reports of positive results! Our new Support Groups are truly contributing to a FULL RECOVERY!

Ground Rules for Support Groups

The following are just some of the ground rules of the Support Groups. These guidelines facilitate trust in the group and enable each person to share what they are going through:

1. We each share the responsibility for making this group work.
2. We try to accept people, just as they are, and we avoid making judgments.
3. We have the right to speak and the right to remain silent.
4. We try to be aware of our own feelings and talk about what is present to us now, rather than what life was like for us in the past.
5. We have the right to ask questions and the right to refuse to answer.

Zambia 2011

We have been working at a remote hospital in Zambia that serves many critically burned children every year. This last trip in June was especially rewarding. In addition to helping the local medical professionals improve their burn care protocols, we initiated a child burn prevention program in two local schools.



Over 800 children participated in a burn education program specifically designed to help them avoid dangerous burn risks in their villages. The Children's Burn Foundation had a coloring book created and translated into their native language as part of the program. A post test, administered on our trip back to Zambia in August, revealed dramatic increase in burn safety understanding and prevention.

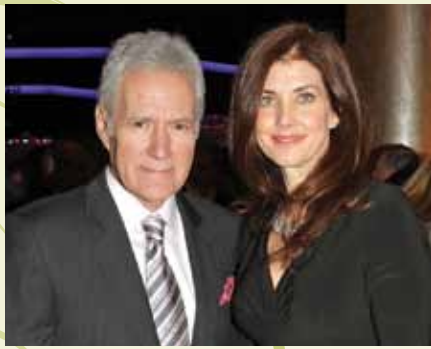

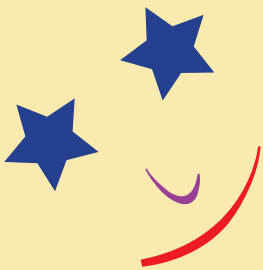

OUR MISSION

To Prevent and To Heal
To prevent the pain and trauma of burn injuries to children, and
To heal and give children who suffered severe burns the opportunity to reach their full potential physically, psychologically and socially.



Fire Safety Tips for Kids

1. Don't touch matches. Stay away from lighters and candles, too.
2. Don't touch radiators or heaters. Ask a grown-up to turn a heater on or off for you. Don't stand too close to a fireplace or wood stove, either.
3. Don't play with electrical cords. And don't stick anything into an electrical socket!
4. Don't play around in the kitchen. If you want to cook something, be sure to check with a grown-up first.
5. Don't put anything over a lamp. Things thrown over a lamp (like blankets or clothing) could heat up and catch fire.

Be Prepared!

1. Make an escape plan. Work with your family to plan how to get out of your home if there is a fire.
2. Plan two ways out of every room. The first way out should be a door.
3. Choose a meeting place. Pick a safe and easy-to-remember spot outside your home where you will meet your family after you get out.
4. Practice! Every escape path needs to be planned and practiced with grown-ups.
5. Test smoke alarms. Help grown-ups remember to test smoke alarms monthly and to put in new batteries twice a year when the clocks change.

If there is a fire, Be Safe!

1. Get out fast! When you hear the loud beep of the smoke alarm, get out of the house. Never hide and never take time to grab your belongings or pets.
2. Follow your escape plan. After all, you've been practicing!
3. Feel a door before you open it. If it is hot, there may be fire on the other side. Try to get out another way.
4. Stay low to the floor. Since smoke rises, the safest air for breathing is down low.
5. Call 9-1-1 or the fire department. Be sure to do this after you get out of the house.
6. Stay out! Once you're out, stay out. Don't go back for anything!

And remember...

Stop, Drop, and Roll. If your clothing catches fire, remember to stop where you are and drop to the ground. Cover your face and mouth with your hands, and roll over and over until the flames are out.



WARNING!

Firepot Gel Taken Off the Market after Burn Incidents with Devastating Results

The U.S. Consumer Product Safety Commission has issued a recall on several pourable firepot fuel gels after devastating accidents injured at least 23 people since March 2011, including 3 children who are known to the Children's Burn Foundation. The flames from the gel fuel are very difficult to put out and the flaming gel sticks to skin and clothing.

If you own these fire pots or pourable gel fuel, DO NOT use them!
